




## BUILDING THE PARTICIPATORY PROCESS


Ist Step: Identifying what is happening on the ground.
2nd Step: Inviting stakeholders working on the ground to present their initiatives.
3rd Step: Delivering the results derived from the information collected.
4th Step: Building on the results to set guidelines for building the REDD+ strategy.
5th Step: Clealrly identify stakeholders demand.
6th Step: Create room for negotiation before passing any Law or Decree.
7th Step: ensuring that the negotiations results will be taken into consideration when proposing any Law, Decree, policy or programs.






